

CONTEST RULES – COUNTY OF HEROES

1. To be eligible to participate you must be at least 13 years of age but not older than twenty-five years of age and attending school, reside in the County of Los Angeles, State of California.
2. If you under the age of eighteen, you must have informed your parent or guardian that you are participating in the contest and your parent or guardian has consented to your participation in the contest which includes attending the County of Heroes presentation which will be a virtual presentation, further described herein.
3. To Enter:
 - a. You must register and participate in a virtual County of Hero presentation that is hosted by a representative of Parents, Educators/Teachers & Students in Action (PESA) by sending an email to the designated email site.
 - b. You must submit your artwork, complying with the instructions as provided by the PESA representative and/or the virtual County of Heroes booklet, available upon request, by either email or mail before the end of the contest.
 - c. Your submission will be entered for the week that is received by PESA.
 - d. You can only enter one time, but more than one person from a family can enter.
 - e. Employees of PESA are not eligible.
4. How to win:
 - a. The contest will commence the week of November 2, 2020 and will continue to May 31, 2021.
 - b. To qualify to win, you must attend a virtual County of Hero presentation and submit artwork as described in the presentation on a timely basis.
 - c. Every week three drawings will be selected from each of the following categories.
 - i. 13-15 years old
 - ii. 16-18 years old
 - iii. 19-25 years old
 - d. The weekly winner from each category will win a prize with a value of \$25. Winners will be notified by email.
 - i. Each weekly winner will receive a prize with a value of \$25.00.
 - ii. Each weekly winner will be eligible for the category prize of \$500.00 as well as the grand prize.
 - iii. To qualify as a weekly winner you must submit your artwork by Sunday of the week you attended a presentation by 11:59 p.m. by email or have it postmarked by said day and time. The email submission address or mail submission address will be provided at the County of Heroes presentations.
 - iv. PESA will have the right to submit the drawing for the following week as a result of a delay in receiving it.
 - v. PESA will have the option to have late drawings received after May 31, 2021 but postmarked prior to that date being entered into a weekly drawing that occurs after May 31, 2021.
 - vi. PESA is not responsible and has the right not to consider a piece of artwork if PESA receives artwork after the final weekly winner is determined as a result of the delay of delivery by the United States Post Office.
 - vii. PESA will have the right:

- a. To publish the artwork for public relations purposes but will not sell or assign the drawing to any other entity.
 - b. Request a photograph of the contest winner with the prize awarded to the contest winner to be used by PESA for public relations purpose but not use the full name of the contest winner without the consent of the parent or guardian of the contest winner.
 - e. The contest winners will be selected by July 1, 2021:
 - i. Three drawings will be selected from each of the following categories:
 - a. 13-15 years old
 - b. 16-18 years old
 - c. 19-25 years old
 - ii. They will win a \$500 gift card.
 - iii. Weekly winners qualify to win. Winners will be notified by email.
 - f. By July 1st, 2021 one piece of artwork will be selected as the Grand Prize winner.
 - i. Winners will be notified by email.
 - ii. Selected from the weekly winners of all the categories.
 - iii. PESA will announce the Grand Prize Winner by July 1, 2021.
 - iv. The grand prize will be a four two day Disneyland Hopper tickets ages 10+ to Disneyland located in Anaheim, California as described on the Disneyland webpage at <https://www.wdwinfo.com/disneyland/tickets.htm> or a prize of equivalent value at the discretion of PESA if it is determined that due to the pandemic the prizes cannot be utilized within a reasonable period of time.
 - v. PESA will have the right:
 - a. To publish the artwork that qualified for the grand prize for public relations purposes but will not sell or assign the artwork to any other entity.
 - b. To take a photograph of the contest winner receiving the grand prize awarded to the contest winner to be used by PESA for public relations purpose but not use the full name of the contest winner without the consent of the parent or guardian of the contest winner.
 - vi. The grand prize winner will designate a parent or guardian to receive the prize on their behalf if they are under the age of eighteen.
 - a. Said parent or guardian and grand prize winner will sign a release stating such as well as a representation that the grand prize will not be assigned or sold and will be used for the benefit of the grand prize winner.
 - b. If the grand prize winner or their parent or guardian fails to comply with this or any other condition of receiving the grand prize, PESA will have the right to determine the grand prize winner has forfeited their right to receive the prize and select another grand prize winner.
5. To be eligible to win either the weekly or grand prize:
 - a. Each entrant must follow all the rules of the contest.
 - b. The Executive Director of PESA will determine if an entrant has followed the rules of the contest and is eligible to win either a weekly prize or the grand prize.

6. In order to qualify for either the weekly prize or the grand prize nothing has to be purchased, the entry is free.
7. Only one entry is allowed per person.
8. Receiving services or making a donation to PESA will not help you win.
 - a. The chances of winning is the same for someone who is receiving services from PESA or is not receiving services from PESA.
 - b. The chances of winning is the same for someone who has donated to PESA or has had a family member or friend who has donated to PESA.
9. Weekly winners or grand prize winners will be notified by email or mail at the sole discretion of PESA.
10. PESA has the right to select the Board of Judges who will determine the weekly and grand prize winner, they can be the same or different individuals, and their decision is final and cannot be challenged by any entrant.
11. PESA has the right to disqualify any entrant if the Executive Director of PESA at his sole decision determines that the entrant violated the rules of the contest or engaged in fraudulent or deceptive acts concerning the contest.
12. Personal information of the contestants:
 - a. Will be used for purposes of the contest.
 - b. Will be used to notify the participants of future contests of PESA or information about presentations or services PESA is offering to the community.
 - c. Will not be sold or provided to any other entity.
13. By entering this contest, each entrant accepts and agrees to be bound by these official rules and the decisions of the Board of Judges. PESA and their agencies are not responsible for any incorrect or inaccurate information, whether caused by website users or by any of the equipment or programming associated or utilized for the contest or by any technical or human error which may occur in the processing of submissions in the Contest. PESA and their agencies assume no responsibility for any error, omission, interruption, deletion, defect or delay in operating or transmission, communication line failure, theft or destruction or unauthorized access to, or alteration of entries. PESA and their agencies are not responsible for any problems or technical malfunction of any telephone network or lines, computer systems, servers or providers, computer equipment or software on account of technical problems or traffic congestion on the Internet or combination thereof, including injury or damage to participants or to any other person's computer related to or resulting from participating or downloading materials in this contest. If, for any reason, the contest is not capable of running as planned, including infection by computer virus, bugs, tampering, unauthorized intervention, fraud, technical failure, or any other causes beyond the control of PESA which corrupts or affects the administration, security, fairness, integrity or proper conduct of this contest, PESA reserves the right to terminate this contest. Entries (including but not limited to the drawings submitted) become the property of PESA and shall not be returned.
